The fee in lieu of open space offer from Hartman Bridge LLC was discussed. The Board directed Deimler to respond the Township requires \$100,000.00 up front with the remaining to be paid in 20% increments over the next 5 years.

This ordinance was in response to a tower erected by Mobilitie outside of the Township right-of-way on private property on White Oak Road in the Township.

On a motion by Weaver/Dearolf, the Board voted unanimously to approve mileage reimbursement for Township employees who use their private vehicles for Township business at a rate of 53.5 cents per mile as per the IRS for 2017.

On a motion by Weaver/Dearolf, the Board voted unanimously to authorize forwarding proposed Subdivision and Land Development Ordinance (SALDO) text amendment Ordinance #105 to the Township and Lancaster County Planning Commission for review. Three administrative points were unintentionally omitted from the original SALDO and this remedies that omission.
