ORDINANCE NO. 122

AN ORDINANCE TO AMEND THE STRASBURG TOWNSHIP TRAFFIC AND PARKING ORDINANCE, ORDINANCE NO. 34, TO IMPOSE A SPEED LIMITATION ON BACHMAN ROAD.

BE AND IT IS HEREBY ORDAINED AND ENACTED by the Board of Supervisors of the Township of Strasburg, Lancaster County, Pennsylvania, as follows:

<u>Section 1.</u> The Strasburg Township Traffic and Parking Ordinance, Ordinance No. 34, Article II, Traffic Regulations, Section 1, Maximum Speed Limits Established on Certain Streets, Subsection (a), shall be amended by adding the following speed limitation in alphabetical order:

StreetBetweenMaximum Speed LimitBachman RoadDieter Road and Lime Valley Road35 mph

<u>Section 2.</u> All other sections, parts and provisions of the Strasburg Township Traffic and Parking Ordinance, Ordinance No. 34, shall remain in full force and effect as previously enacted and amended.

<u>Section 3.</u> In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Ordinance, it being the intent of the Board of Supervisors that the remainder of the Ordinance shall be and shall remain in full force and effect.

<u>Section 4.</u> This Ordinance shall take effect and be in force five (5) days after its enactment by the Board of Supervisors of the Township of Strasburg as provided by law.
